Following its 2023 first edition, the Graduate School of Law of the University Paris-Saclay is proud to invite you to its second International Summer School, from June 17 to 21, 2024, at the Jean-Monnet Law School, on the Sceaux campus.

**Hugo Acciarri**

Hugo Acciarri is a Professor of Law and of Law, Economics and Behavior at the National University of South, Bahía Blanca, Argentina, where he chairs its Program of Law, Economics and Behavior. He is also a post-graduate professor at the University of Buenos Aires, Argentina.

He authored and edited books and chapters of books in the field of Law and Economics published in North and South America, as well as in Europe, and research papers on Tort Law, Contract Law, Consumer Law, Litigation, Compliance, Law and Economics and Behavioral Law and Economics.

As a visiting scholar and visiting professor, he taught courses, seminars, and lectures, and presented research at the Universities of Harvard; Columbia; California, Berkeley; Chapman, Los Angeles; Paris I (Panthéon-Sorbonne), Paris-Sud (presently, Paris-Saclay); Autónoma, Complutense, Carlos III, Madrid, Pompeu Fabra, Barcelona (Spain), Autónoma (México), among many others.

He received the *2008 Microsoft Research Award for Scholarship on Law and Economics* and the *2010 Life Achievement Award for Development in Law & Economics in Latin America* (University of California, Berkeley and ALACDE) among others.

The University San Martín de Porres (Lima, Perú), conferred the title of Honorary Professor on him in 2010. He was also elected to the National Academy of Law and Social Sciences, Córdoba, Argentina in 2013.

He was appointed as President of the Latin American and Iberian Law and Economics Association (2013-2017).

**Maria José Azar-Baud**

Maria José is an expert in Collective redress in Comparative law. Associate Professor at University of Paris-Saclay and lecturer at several national and international Universities, namely University Paris 1 Panthéon-Sorbonne (Consumer Dispute Resolution) and Paris 2 Panthéon-Assas (European Union Consumer law), at Masters' degree, her main areas of teaching and research are Consumer law, International Contracts and Comparative procedural law.

Maria José holds a double PhD from Paris 1 Panthéon-Sorbonne University and the University of Buenos Aires focusing on Collective actions in Consumer law in France and Argentina, under a Comparative Law perspective. The French editor Dalloz published her thesis in 2013.

She is the author of more than 100 contributions in three languages, mainly related to class actions, collective, representative and group actions, in the fields of procedural law, torts and liability, consumer law, environmental law and discrimination. As a member of several scholarly institutions, Maria José has been heard in matters of group and collective actions in general in the Senate, the National Assembly and several agencies in France, as well as in the European Parliament, as one of the main authors of the Study on Collective redress in the EU Member States requested by the European Parliament ([http://www.europarl.europa.eu/RegData/etudes/STUD/2018/608829/IPOL\\_STU\(2018\)608829\\_EN.pdf](http://www.europarl.europa.eu/RegData/etudes/STUD/2018/608829/IPOL_STU(2018)608829_EN.pdf)).

Maria José co-chairs the Institut Droit Éthique Patrimoine (IDEP) and the Paris-Saclay Legal Clinics. She founded the Observatory of Group Actions and other forms of Collective Redress ([www.observatoireactionsdegroupe.fr](http://www.observatoireactionsdegroupe.fr)) in 2017, an international platform for researchers and practitioners aimed at collecting data related and analysing it from an interdisciplinary point of view.

She began her career as a lawyer at the Bar of Buenos Aires and has extensive experience in the practice of collective actions and the negotiation of amicable collective settlements on behalf of consumer associations in Argentina.

Currently, aside from lecturing, Maria José is an attorney-at-law at the Bars of Paris and of Buenos Aires, and as international counsel, she advises on mass disputes' resolution and seats at the Executive Board of two European non-profit organisations acting as plaintiffs in mass tort cases and seeking to grant access to justice on a collective scale.



**Anaïs Brosse**

Anaïs Brosse is an associate professor in the BaPS team at the Micalis Institute (UMR1319 Paris-Saclay University, INRAE, AgroParisTech). After defending her Ph.D. thesis on mixed regulatory circuits between two-component systems and regulatory RNAs in Escherichia coli in 2017, A. Brosse continued

to work on this topic for three years as part of a postdoctoral project. In 2020, A. Brosse obtained a position as Associate Professor at the University of Paris-Saclay and developed a new research theme concerning the link between microbiota and CD infection. In particular, she initiated the study of the potential use of bifidobacteria for the prevention and treatment of CDI, which is a new topic in the BaPS team.

In terms of teaching, she is involved in Industrial Microbiology in the Master 2 programs "Drug Quality Control", "Quality Management" and "Medical Devices" at the Faculty of Pharmacy, Université Paris Saclay. She also lectures on microbiota topics. Finally, she is involved in the theme of "Infection Prevention and Antibiotic Resistance" in the "Service sanitaire". The goal of this course is to help students create media (oral presentations, games, quizzes, mini-experiments, etc.). These materials are then used by students as part of an intervention to disseminate public health messages.

Finally, she has been actively involved in popular science events for several years.



**Amaury Dubois**

Amaury Dubois (University Paris-Saclay Alumnus 2022) is a lawyer at CMS France. He is involved in Banking & Finance on a wide range of domestic and cross-border transactions and in particular in project financing. He advises lenders, borrowers, sponsors, governments and public entities on infrastructure and energy projects in France and abroad. He also regularly assists start-ups and SMEs in their development and financing.



**Aude Farinetti**

Aude Farinetti is Ass. Pr. in public law at Université Paris Saclay, specialising in environmental law and co-director of the M2 "Environmental Law". She defended her thesis on the legal protection of watercourses at the Université Jean Moulin Lyon 3 and has contributed to various research programmes on wetlands, environmental assessment, the proliferation of sargassum algae in Martinique and water quality.





**Sylvain Franger**

Sylvain Franger is Professor of Electrochemistry at Paris-Saclay University. He is the head of the Energy Master program (including 10 different tracks, involving 100 students), and leads a research team at the Institute for Materials and Molecular Chemistry (ICMMO, UMR CNRS 8182). His research interests include the deep investigation of the electrochemistry and cycle life performance of secondary batteries for both stationary and automotive applications. He has supervised 12 PhD students and is now involved in the supervision of 5 ongoing PhD works dealing with electro-thermo-mechanical modeling of Li-ion batteries, electronic/ionic limitations in commercial batteries electrodes, and development/characterization of innovative all-solid-state-batteries.

Sylvain Franger filled 9 patents (5 with private companies), published 76 papers, and gave 56 invited lectures. He has been involved in one technology transfer concerning a new environmentally friendly material for Li-ion battery. He is expert for the European Union in the domain of energy storage, and member of the steering committee of the French PEPR Batteries.



**Géraldine Goffaux Callebaut**

Géraldine Goffaux Callebaut is Professor of Private Law at the University of Orléans. She is co-director of the Master in Cultural Heritage Law (Paris-Saclay University) and the Master in Art Market Law (École du Louvre).

She is a member of the Pothier Research Centre, where she heads the Organisations and Governance section. She is also a research associate at the Institut Droit Éthique Patrimoine (Paris-Saclay University) and a research associate at the Regroupement Droit Changements et globalisations (RDCG, University of Montréal).

Her research and teaching focus on business law and cultural and artistic heritage law. In business law, she has conducted extensive research on ethics and corporate social responsibility (since 2014), with a normative approach. She is also interested in the legal issues raised by new technologies (electronic voting, blockchain, AI). She is currently leading a regional project on Law & ethics of digital transformations.



**Liane Huttner**

Liane Huttner is a senior lecturer at Paris-Saclay University. She specialises in digital law and personal data law. She defended her PhD at the University of Paris 1 Panthéon-Sorbonne on Algorithmic decision making, analysing the relationship between humans and machines in decision-making. She co-created the Catala computer language with a computer scientist, the aim of which is to offer a user-friendly technology for translating law into computer code.



**Patrick Jacob**

Patrick Jacob is professor of international law at the university Paris-Saclay (UVSQ). He is co-director of the Master's Program on International and European Law. At Paris-Saclay, as well as in other academic institutions (Sciences Po and Paris 2), he teaches public international law and international economic law, with a special focus on international investment law. He has published extensively on various issues of international law, especially the law of international responsibility and international investment law. For two years, he acted as one of the co-convenor of the 3IPEP project, which gathered teachers and researchers from three academic institutions (UVSQ, ULap (Rovaniemi, Finland) and RGSL (Riga, Latvia)) in order to tackle the legal issues raised by the existence and development of international investments affecting indigenous peoples and the environment, with a special focus on the arctic region.



**Mathilde Lacaze-Masmonteil**

Mathilde Lacaze-Masmonteil (University Paris-Saclay Alumnus 2021) is an attorney-at-law at the Paris' Bar, specializing in environmental law and focusing her practice on environmental compliance and corporate social responsibility. Her main area of practice is on the environmental perspective of the Duty of vigilance law, as she regularly advises companies on their compliance with the 2017 legislation.



She also helps companies define their sustainable development strategy in alignment with the Paris Climate Agreement.

She is involved in ongoing strategic litigations aimed at establishing the State's responsibility for the inadequacy of climate policies (*Affaire du Siècle* and *Grande Synthe* cases) and in the overuse of pesticides (*Justice pour le vivant*). She is particularly interested in environmental liability and the protection of biodiversity. She advises environmental NGOs on these issues (whether from a criminal, civil or administrative perspective).

She is a former student of the M2 Environmental Law of Paris-Saclay and holds a degree in Environmental Engineering and Management from Mines ParisTech. She seats at the executive board of the Mines ParisTech alumni association. She also teaches corporate social and environmental responsibility in different programmes at the University Paris-Saclay.

She is the author of several contributions related to these topics for Lefebvre Dalloz, Lexisnexis or l'Observatoire du Green Deal.



**Pierre Lequet**

Pierre Lequet is a Tenured Associate Professor of Law at Université Polytechnique Hauts-de-France. He is Director of the Master's Program on 'Real Estate Law and Finance'. He also teaches and lectures at other universities such as CY Cergy Paris University or Paris Sciences & Lettres University.

For more than ten years, Pierre devotes most of his research to environmental economic law. More precisely he wrote numerous articles about corporate duty of care, sustainable consumer law, ecological impact of digital technology, Dieselgate in the context of contractual litigation and the protection of whistleblowers. He also works on issues more specifically related to business law.

He is affiliated to expert associations such as Société Française de Droit de l'environnement.



**Marie Malaurie-Vignal**

Marie Malaurie-Vignale is Full Professor at Paris Saclay University. She is the Scientific manager of the journal *Concurrence Consumption Contracts* (LexisNexis), Member of the IEJ Board of Directors of UVSQ University and of the scientific committee of the International Summer School of the University of Paris Saclay.

She is a Specialist in Economic law, competition law, distribution law and intellectual property law. She is the Author of books on competition law and distribution law (Dalloz-Sirey ) and makes Regular publications in legal journals and collective works in French and in English journals (*Blockchain, intellectual property and fashion, Journal of Intellectual Property Law & Practice*, Volume 15, Issue 2, February 2020, Pages 92–97, <https://doi.org/10.1093/jiplp/jpaa009>; *Intellectual property law and parodies in the fashion industry*, Marie Malaurie-Vignal and Stéphanie Legrand, *Journal of Intellectual Property Law & Practice*, Volume 14, Issue 6, June 2019, Pages 459–471, <https://doi.org/10.1093/jiplp/jpy176>; *Could fashion copies become lawful?* , *Journal of Intellectual Property Law & Practice*, Volume 13, Issue 8, August 2018, Pages 657–663, <https://doi.org/10.1093/jiplp/jpy002>).

She is currently focusing her research on digital (algorithms and competition, regulation of platforms) and on craftsmanship and local know-how.

She has carried out Collective research with the scientific organization of symposia on digital (symposium June 5, 2023 on e-reputation"; symposium on influencers March 2, 2020, <https://www.delcade.fr/2020/10/14/colloque-mode-influenceurs/>; conference on blockchain, 17 May 2018, <https://www.ifmparis.fr/fr/actualites/colloque-blockchain-propriete-intellectuelle-et-mode>) and conferences on the protection of know-how (symposium of June 27, 2022 on Made in France and promotion of quality and know-how, <https://www.idep.universite-paris-saclay.fr/manifestations/made-in-france-and-valorisation-de-la-qualite-et-du-savoir-faire-27-June-2022>; colloquium 3 Dec. 2018 on parody and fashion . All these colloquia have been published in French journals.



**Véronique Magnier**

Véronique Magnier is Full Professor of Law and the Director of the Graduate School of law at University Paris-Saclay.

She devotes most of her research to corporate law, corporate governance and business ethics from national, comparative, European and International perspectives. She is the co-author of the textbook *Traité de Droit commercial-Ripert et Roblot-* (LGDJ ed., last ed. 2022), and the author of two monographies, one in English, « *Comparative corporate governance, Legal perspectives* » (E. Elgar ed., 2017) and another in French : *‘Déontologie et éthique d’entreprise* (France University Press ed., 2023). She coordinated and co-authored books on various topics : *‘La gouvernance des sociétés cotées face à la crise’* (LGDJ, coll. *Droit des affaires*, 2010), *‘Entreprise et développement durable’* (Dalloz, 2013), *‘Blockchain et droit des sociétés’* (Dalloz, 2020), *‘Commentaire article par article de la directive*

2019/1937 sur les lanceurs d'alerte' (Kluwer-Larcier, 2023). She regularly participates in conferences in Europe, North America and Asia.

She is currently the co-Director of the Master's Program on 'Business, Tax and Financial Market Law', the founder of the Master's Program on 'Law, Entrepreneurship and Digital' (LEAD), of the international Program 'Law and Advisory', and of the Paris-Saclay legal clinics. She is also involved in annual Executive programs for business lawyers and judges. As an Adjunct Professor at Georgetown University Law center, she teaches an annual course for LLM international students, 'Comparative corporate governance', since 2010.

For ten years (2009-2020), Véronique was the director of a research institute at Paris-Saclay University, the Institute 'Droit Ethique Patrimoine'. As an active member of the board of directors of the NGO Transparency International France since 2014, she also participates in debates on draft legislation and supports companies in their compliance programs. She is affiliated to expert associations such as Société de Législation comparée, Trans Europe Experts, Institute for Corporate Governance.



**Séverine Péchiné**

Séverine Péchiné, Pharm. D., Ph.D., is Full Professor of Bacteriology at the Faculty of Pharmacy, University of Paris-Saclay, in the Department of Microbiology since 2021. Her research focuses on the bacterium *Clostridioides difficile* and different therapeutic approaches to combat infections associated with this enteropathogen. She is co-director of the Master 2 in Microbiology "M2 Microbiology (Bacteria, Viruses, Parasites): Microbiota, pathogens and anti-infective therapies". She teaches Bacteriology, Infectiology and Vaccinology.



**Bérénice Schell**

Bérénice Schell is a pharmacist and medical biologist. She is doing a PhD in haematology at INSERM. At the same time, she is a volunteer with Les Shifters, leading conferences and workshops to popularise

science and raise awareness on climate and health issues. She sees Les Shifters as a unique opportunity to combine her passion for science with the climate and energy challenges we face today.



**Stephen Park**

Stephen Park is an Associate Professor of Business Law at the University of Connecticut School of Business.

Stephen's research is in the areas of international financial regulation, international trade law, corporate social responsibility and accountability, and corporate compliance. His current scholarship primarily focuses on sustainability and ESG issues in financial regulation, corporate law, and international economic law. His research has been published in the *American Business Law Journal*, the *American Journal of International Law*, the *Harvard International Law Journal*, the *Yale Journal of International Law*, the *University of Pennsylvania Journal of Business Law*, the *Boston College Law Review*, and the *Journal of International Economic Law*, among other academic journals, and in contributions to edited volumes published by Cambridge University Press, Edward Elgar, and Wolters Kluwer. He is a recipient of the Academy of Legal Studies in Business's Distinguished Early Career Achievement Award, given in recognition of demonstrated excellence and exceptional promise in research, teaching, and service.

At UConn, Stephen is co-founder and co-director of the Business and Human Rights Initiative (a partnership between the School of Business and the Human Rights Institute), co-academic director of the Corporate and Regulatory Compliance Graduate Certificate Program (co-administered by the School of Business and the School of Law), and academic director of the Executive MBA Program and serves as a member of the President's Committee on Corporate Social Responsibility.

Stephen is a Visiting Professor of International Law at The Fletcher School at Tufts University, an Affiliated Scholar of the Sovereign Debt Forum (Centre for Commercial Law Studies at Queen Mary University of London and the Institute of International Economic Law at Georgetown University Law Center), and a staff editor of the *American Business Law Journal*.

Stephen holds a J.D. from Harvard Law School, a M.A.L.D. in International Affairs from The Fletcher School at Tufts University, and a B.A. in Ethics, Politics, & Economics from Yale University.
